Stud fees vary depending on the dog to whom he is bred, and the projected price of the puppies. The minimum stud fee is \$900.00. The stud service is offered as artificial insemination only. We do not offer live cover. The owner of the bitch is responsible for all AI collection, insemination and/or shipping fees. One shipment of fresh, chilled semen will be shipped Federal Express to the approved breeder at a cost of approximately \$200 to \$250.

1. A total of one collection is offered with fresh chilled semen which can be delivered overnight to the dam's vet for AI or the dam and dam owner may travel to Montrose, Colorado and our veterinary facility will proceed with a direct transfer of semen during ovulation. All collection and certifications will be handled by a licensed veterinarian. Included in that service will be a sperm count and motility test to assure viability.
2. At the signing of the contract the stud owner will provide all appropriate pedigree and health documentation on Alpine's Majestic Splendor.
3. Stud fee will be paid prior to the first shipment of fresh, chilled semen.

4. The dam owner pays for all collection service and delivery fees depending on type of shipping. Fees and services are paid directly to the stud owner.
5. Three live puppies will constitute a litter. If no litter is produced from this breeding, the stud owner will offer a repeat breeding to the same dam at no additional stud service fee. Dam owner will be responsible for repeat collection and shipment fees. If there are only two live puppies or a single puppy the original stud service must be paid and a repeat breeding will be offered. If there are no live puppies the original stud service may be refunded OR a repeat breeding will be offered.
6. The dam owner will pay all costs associated with AI and all other reproductive services. It is required that the dam owner will have progesterone tests performed on their dog to help determine the best time for insemination by a qualified vet.
7. The stud owner assumes no responsibility for injury, illness, or death associated with AI.
8. The dam owner will provide the stud owner a copy of the genetic tests performed, and preliminary or full OFA score or PennHip score of the dam prior to shipment of semen. Current planned use of Alpine's Majestic Splendor stud service is for the above listed bitch only. No other bitch will be used for Alpine's Majestic Splendor's stud services without written permission of the stud owner.
9. Dam owner must provide stud dog owner information regarding puppies born in a litter, including date of whelping, the number of puppies born, gender, and color.
